Precautionary Statements

Prevention:

4. FIRST AID MEASURES

Inhalation:	Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. If symptoms develop and persist, get medical attention.
Skin contact:	Remove contaminated clothing and footwear. Immediately flush skin with plenty of water (using soap, if available). If symptoms develop and persist, get medical attention. Wash clothing before reuse.

5. FIRE FIGHTING MEASURES

Extinguishing media:	Foam, dry chemical or carbon dioxide.

Unusual fire or explosion hazards:	Closed containers may rupture (due to build up of pressure) when exposed to extreme heat. Vapors may travel considerable distance to source of ignition and flash back.

6. ACCIDENTAL RELEASE MEASURES

Use personal protection recommended in Section 8, isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions: Do not allow product to enter sewer or waterways.

Clean-up methods: Ventilate area. Remove all sources of ignition. Evacuate personnel to safe areas. Wear suitable protective clothing, gloves and eye/face protection. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Store in a partly filled, closed container until disposal. Spilled liquid is combustible and can be ignited by heat, flames, sparks, or other sources of ignition. Refer to Section 8 "Exposure Controls / Personal Protection" prior to clean up.

7. HANDLING AND STORAGE

Handling: Keep away from heat, spark and flame. Keep container closed. Use only with adequate ventilation. Empty containers retain product residue, so obey hazard warnings and handle empty containers as if they were full.

Storage: Store away from ignition sources. Store in original container until ready to use. Keep away from heat, spark and flame.
