**Precautionary Statements**

**Prevention:**

**Response:**

### 4. FIRST AID MEASURES

<b>Inhalation:</b>	Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. If symptoms develop and persist, get medical attention.
<b>Skin contact:</b>	Remove contaminated clothing and footwear. Immediately flush skin with plenty of water (using soap, if available). If symptoms develop and persist, get medical attention. Wash clothing before reuse.
<b>Eye contact:</b>	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get immediate medical attention.
<b>Ingestion:</b>	Do not induce vomiting. Never give anything by mouth to an unconscious person. Get immediate medical attention.

**Clean-up methods:**

Refer to Section 8 "Exposure Controls / Personal Protection" prior to clean up. Ventilate area. Remove all sources of ignition. Evacuate personnel to safe areas. Wear suitable protective clothing, gloves and eye/face protection. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Store in a partly filled, closed container until disposal. Spilled liquid is combustible and can be ignited by heat, flames, sparks, or other sources of ignition.

## 7. HANDLING AND STORAGE

**Handling:**

Keep away from heat, spark and flame. Keep container closed. Use only with adequate ventilation. Empty containers retain product residue, so obey hazard warnings and handle empty containers as if they were full. Prevent contact with eyes, skin and clothing. Do not breathe vapor and mist. Wash thoroughly after handling.

Store away from ignition sources. Keep away from heat, spark and flame. Store in original container until ready to use.
